1. Application Form.
2. Project Confirmation Letter.
3. Lead Partner / Project Partner Statement.
4. Documents if NGO is Lead Partner.
5. Documents for infrastructure works.
6. Documents for installation of outdoor equipment that do not require technical documentation.
7. Documents for environmental activities.
8. Any other supporting documents that the applicant thinks are necessary.
